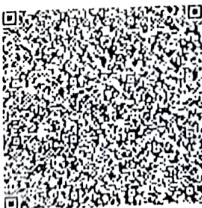

"Kaushalya- The Skill University "under the Labour, Skill Development and Employment Department and having its registered office at Mahatma Gandhi Labour Institute (MGLI), Drive-in Road, Memnagar, Ahmedabad – 380052, aims to promote skill-based education, skill development, entrepreneurship, reskilling and upskilling as well as facilitating research in emerging areas in primary, secondary and tertiary industries in Gujarat (hereinafter referred to as "Skill University /FIRST PARTY)

AND

"Swarnnim Institute of Skill Development (SISD)", a constituted institute of Swarnnim Startup & Innovation University, engaged in the business of (Education Sector, Health Science Sector, Skill Development, Vocational Training) having its registered office at Village : Bhoyan Rathod, Opposite IFFCO, Near ONGC – WSS, Gandhinagar, Gujarat. Pin – 382420. Owned and managed by Swarnnim Startup & Innovation University, Gandhinagar (hereinafter referred to as "The Institute"), which expression shall, unless it be repugnant to the subject or context thereof, include its successors and permitted assignees) of the **SECOND PARTY**;

Primary objectives of the Skill Institute are,

- i. To conduct Degree, Diploma and Certificate courses as approved by Skill University including both Short Term and Long Term courses as per market demand. The details of these courses will be submitted subsequently by the Institute.
- ii. To Train the Trainers of ITIs, Prime Minister Kaushalya Vikas Yojana as well as other trainers (Government and Private Skill centers).
- iii. Demonstration of latest technologies, skills and products based on market requirement.
- iv. Research and consulting assignments.
- v. Organizing training and competition for World Skill Competition at state, regional and national levels.

The Centre is expected to train more than 3000 youth per year. Center will carry out necessary publicity, carryout awareness drives among target group. (Center can describe their training model/Pedagogy/Uniqueness)

1. Roles and Responsibilities of the parties

1.1 Role of the Skill University:

- a) Grant affiliation of course/s run by Skill Institute subject to norms of the University.
- b) Carry out Semester end Assessment of the affiliated courses as Specified.
- c) Award Credit/Degree/Diploma Certificate and Marksheets to successful candidates.
- d) Work jointly to promote common objectives of the course/programme.



- e) Promote the Courses on their Website and in ITIs and Other Government Institutions.
- f) Provide teaching Support to the Institute in carrying out the academic functioning when ever feasible.

1.2 Role of SIDC:

- a. Provide all training facilities including but not limited to theory, practical, demonstration, Laboratories, workshop as per the norms for the course.
- b. Deploy qualified and experienced faculties for imparting learning.
- c. Deploy necessary resources for functioning of the institute.
- d. Ensure quality training.
- e. Arrange on the job training/Internship as specified in curricula/necessary.
- f. Provide NSQF Level 4 or above courses unless specifically permitted. (Institute) will obtain necessary approval of NSQF.
- g. Organize time to time subject experts' visit to center for educating the trainees.
- h. Extend help for placement of passed out candidates.
- i. Work jointly to promote common objectives of the course/programme.
- j. Conduct ToT for Instructor as specified by the University.
- k. Level 3 Courses may also be provided in 1st year to non ITI Students.

2. Mode of operation

- a. Institute will be Self-financed and therefore, it will be open to participants from the open market and charge appropriate fee in consultation with the University.
- b. Admission of the trainees will be made in a transparent manner.
- c. Curriculum and Assessment will be done as per University Guidance.

3. Duration of the Project: The duration of the Agreement will be 5 years from the date of signing of the agreement

4. Dispute Resolution: In case of any dispute, the case to be escalated to the level of the committee comprising Director General and Head of the Company / foundation. Decision of the committee shall be binding.

5. Effective date, Terms and Termination

- a) The Effective date shall be the date on which the Agreement would be signed and shall be valid for a period of 5 years. The Agreement may be extended for such further tenure as may be mutually agreed by and between the Parties in writing to serve its intent and purpose.
- b) Termination of the Agreement will not be done without prior permission from University. In any case if the same is approved the Institute shall continue functioning till existing students graduate fully.

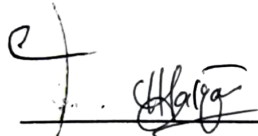

This Memorandum of Understanding is made on this 14th December, 2021 at Ahmedabad.

BETWEEN

Venus Institute of Physiotherapy constituent institute of **Swarnim Startup & Innovation University, Managed by G.P. Jain Charitable Trust**, having its address at Bhoyan Rathod, ONGC WSS, Adalaj-Kalol Highway, Gandhinagar-382420 herein after referred to as "College" (This expression shall mean and include its present office bearers and executors in the interest of educators, administrators and assignees) of the
FIRST PART

AND

Shalby Academy, A Unit of Shalby Limited, having its office at Shalby Hospital, Opp. Karnavati Club, S. G. Highway, Ahmedabad-380 015 hereinafter referred to as the "Shalby Hospitals" or "Shalby Academy" (which expression shall unless repugnant to the context, be deemed to include its successors, executors, assigns and agents) on the **having Units of Shalby Hospital as per Annexure B** (attached below) on the **SECOND PART**.

WHEREAS

1. COLLEGE has approached Shalby Academy to impart practical training/internship/clinical posting to their Students at Shalby Hospitals unit situated in Ahmedabad or other units situated in India.
2. Both the parties have decided and entered into this Memorandum of Understanding on the terms as recorded hereinafter.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS UNDER:

Rights & responsibilities of College & their Students

1. College shall notify Shalby Hospitals in writing in advance, i.e. 15 days before proposed training/clinical posting/internship schedule.
2. The College shall be responsible to inform the Shalby Hospitals in case of any changes in decisions regarding training activities such as change in the schedules etc.
3. Students/Trainees of College shall be strictly bound to follow rules, regulation and policies enforced from time to time by Shalby Hospitals including the right of entry into the premises of Shalby Hospitals.
4. College shall be responsible to provide Identity card to their students and staff members to allow them entry into the premises of Shalby Hospitals.



5. College and its students shall not disclose or use any confidential information, documents and any other hospital policies gained in the course of training period with Shalby Hospitals, for their personal gain or for advantage of any other person. No information shall be provided to any external agency, formally or informally.
6. College shall be responsible to indemnify to Shalby Hospitals any financial loss due to any accident, hazards caused to the Shalby Hospitals by the student of College in the premises of Shalby Hospitals.

COLLEGE/ Students shall pay to Shalby Academy as agreed herein:

Course Name	Minimum No of Students	Training cost per student per month (INR)
Clinical posting of Physiotherapy Students(BPT/MPT)	10	Rs.1000 + GST
Internship Final year BPT students	05	Rs.5000 + GST

Internship can be done at Shalby Hospitals units

If number of student increases beyond Minimum numbers agreed above, then proportionate fee will be additionally charged.

No student will be permitted to undergo Internship / Postings if the payment of fee is not received in advance.

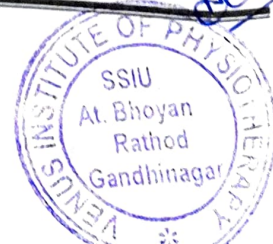
All payments to be made in favour of "Shalby Academy"

Rights & Responsibilities of Shalby Hospitals

1. Shalby Hospitals reserves its right to alter, reject or change the training schedules to safeguard the interest of Hospitals, its patient etc.
2. If number of breach of rules of the Shalby hospital by students collectively exceeds five, Shalby hospitals shall inform the same to College and Shalby Hospitals shall have right to terminate this arrangement with immediate effect.

TERM PERIOD& MISCELLANEOUS

1. This Memorandum of Understanding (MOU) will remain in force for a period of **two Years** effective from date of signing of this MOU unless either party terminates the same by giving 30 days prior written notice. Without prejudice, Shalby Hospitals reserves its right to cancel this memorandum of Understanding in the event it is found that College or any of its students have acted contrary to the obligations contained in this Memorandum of Understanding. The decision of Shalby Hospitals, in such cases, shall be final.



2. Both the parties shall use each other's trade (brand) name/logo so as to indicate their association with them subject to taking prior written approval from each other.
3. No modification, variation, waiver or amendment of any term or condition of this agreement shall be effective unless and until it shall be reduced to writing and signed by both the parties thereto.
4. The signatory of this MOU is having a requisite authority under the construction of the respective organization to execute this MOU.

Arbitration & Jurisdiction

1. Any dispute arising out of this MOU shall be mutually resolved first and if required it may be referred to common arbitrator appointed by the parties to resolve the same.
2. Any dispute, differences, controversies or claims arising out of or relating to this MOU are subject to exclusive jurisdiction of Courts at Ahmedabad only.
