Eligibility Criteria under Government Scheme

Parameter	Relaxation on fees Subject to
The candidate if applies on Government Scholarship scheme- Digital Gujarat scholarship Portal	The candidate if SC/ST caste, domicile of Gujarat gets the benefit of full fees from the Government as per FRC.
The candidate if applies on Government Scholarship scheme- MYSY .	The candidate if, the domicile of Gujarat gets the partial fees benefit from the Government as per respective programs.
The candidate if applies on Government Scholarship scheme- CMSS .	The candidate if the domicile of Gujarat gets the partial fees benefit from the Government subject to the following conditions: if father is no more, Divorcee, Shramik card, 40 percent physically disabled. Martyrs' son/daughter, if the candidate's father is injured during war.

Eligibility Criteria

Parameter	Approved Relaxation on fees
The candidates If Team members of Swarnim Group pursue course	50% relaxation on Tuition fees & Development fee shall be paid fully
The candidate If Son/daughter of the employee of Swarnim Group	Up to 50% Relaxation on Tuition fees
The candidate If blood relations/kin and kith of the employee of Swarnim Group	10% of 1 st year Tuition fees
The candidate referred by the employee of Swarnim Group	Rs 10000 one time on Tuition fees to student or candidate
The candidate whose parent's income is less than Rs 1 lakh	Rs 10000 to 20000 one time on Tuition fees.
The candidate if produces death certificate of parents.	Rs 10000 to 40000 one time on Tuition fees.
The Candidate if the Alumni of the university	Rs10000 to 20000 per year on Tuition fees.

* Applicable to all courses having Tuition Fee/Year less than 1 Lac Rupee. Approval of Scholarship will be given by Management for courses having Tuition Fee/Year more than 1 Lac Rupee, Case to case basis.

* The Scholarship Scheme is available to employees of the Swarnim Group as long as they remain employed with the organization. If an employee leaves their position, any fee relaxation or scholarship benefits will be revoked immediately.
