3. Discussion on Mission Statement

- Discussions focused on whether the Mission accurately reflects the institution's core values and goals.
- Feedback was received on making the Mission more action-oriented and measurable.

- **Proposed Changes:**

- Include specific goals related to education quality, research in Ayurveda and community service.
- Ensure that the Mission statement reflects a commitment to diversity, sustainability, and innovation.
- Streamline the language to make it more direct and engaging.

4. Policy Alignment with Vision and Mission

- **Proposed Policy Updates:**
