4	Motivate faculty to attend for FDP/seminar/workshop	Most of faculty members attended the FDP/seminar/workshop .

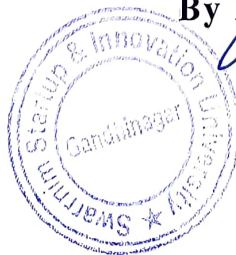
