Article 1: Scope

This MOU is a framework agreement. Its purpose is to describe the nature of cooperation and to suggest the guidelines for future agreement on specific activities planned by the faculties or institutions involved. Individual agreement must be codified in a separate Addendum to this agreement.

Article 2: Cooperation Terms

- A. Both Parties shall make efforts to implement the MoU and develop mutually beneficial cooperation on terms of reciprocity.
- B. The aim of the Memorandum of Understanding shall be to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both Parties.

Article 3: Areas of Collaboration

The areas of cooperation and exchange may include;

- A. Exchange of Scientific Information, Academic Materials, Publication, etc., and Cooperate in the Exchange of Information relating to their activities in academics and research in fields of mutual interests;
- B. Promote appropriate joint projects and with particular emphasis on internationally funded projects;
- C. Endeavour to encourage students for the "University". The Admission of students will be dependent on the execution of a formal Student Agreement prior to commencement of this activity;
- D. To collaborate, partner and engage with any other person, institute University, NGO and Government agencies, private or public funded companies in research, training and innovations in areas of mutual interest.
- E. To promote, advertise, and disseminate the information relating to their activities in academics and research in fields of mutual interests;
- F. Conduct cultural projects, a mutually agreed in writing between the parties prior to commencement of this activity;
- G. Organize study tours, a mutually agreed in writing between the parties prior to commencement of this activity.
- H. Other mutually agreed upon educational programs.

Article 4: Objectives

- A. To develop the academic cooperation in international education between the two Countries (India & Uganda).
- B. To stimulate and facilitate the development of collaborative and mutually beneficial educational programs which serve to enhance the intellectual life and cultural development.
- C. To contribute to increased international cooperation.
- D. Facilitate the admission of undergraduate as well as post graduate students. Such admissions or exchanges may take place for a period of academic year. The academic standing of such students shall be determined by "University" in Gujarat, India.
- E. To assist the admission of students in the host country in accordance with the regulations of the "University" relating to students and will be admitted under the terms and conditions relevant to the "University".
- F. To develop an articulation agreement and policies for students to apply for admission to selected degree programs at "University".

Article 5: Academic Arrangements:

- A. Admission to a specific department or course is subject only to a student being satisfactorily qualified for the chosen area of study and to the availability of resources in the period for which admission is sought.
- B. The host institution agrees to assist in the seeking of appropriate housing, and to supply work space, library and technical facilities as appropriate to students.

Article 6: Financial Arrangements

- A. Both parties agree that all financial arrangements will have to be considered on a case by case basis and will depend on the availability of funds, irrespective of the source of funding, both parties further agree to offer assistance and courtesy to the visiting scholars and students in every possible way.

B. In the implementation of specific cooperative programs or policies, a written agreement covering all relevant aspects including finance and the obligations to be undertaken by each party will be negotiated, mutually agreed and formalized in writing, prior to the commencement of the program.

Article 7: Principles of Equal opportunity and Non-Discrimination

It shall be understood that both the "Agency" and the "University" subscribe to the principal of equal opportunity and shall not discriminate on the basis of race, age, sex, sexual orientation, physical or mental disability, religion, ancestry or national origin, marital status, genetic information, and gender identity or expression. Both the parties shall abide by these principal in the administration and implementation of this Agreement and individual undertakings and neither party shall impose criteria that violate principles of non-discrimination on the selection of scholars or students.

Article 8: Subsidiary Agreements

The parties understand that this Agreement cannot detail how each collaborative project will be implemented, administered, or funded. As a result, the parties shall enter into separate written subsidiary agreements for each project they agree to undertake. Each subsidiary agreements will address the scope of work; each party's contributions and obligations to the project; the administration, coordination and implementation of the project; the respective rights of each party to own, use and license intellectual property that is developed in the course of the project, and other issues the parties may mutually agree to address. Each subsidiary agreement must be signed by an authorized representative of each party to the start of work.

Article 9: Entry and Visa Requirements for Visiting Staff and Students

Both parties acknowledge that visits by staff and students from one institution to the other shall be subject to the entry and visa regulations of India and Uganda, and also shall comply with the regulations and policies of the “Agency” and the “University”, Gujarat, India.



Article 10: Term and Renewal of MOU

This agreement shall be valid from the date of signature of the last party to sign it and will remain valid for **Five (5) Years**. Prior to the expiration date, the agreement may be reviewed for possible renewal. In Case either Party wishes to make amendments or revisions to this Agreement, the other Party shall be notified in writing in six months earlier. Such amendments and revisions shall be made in writing upon mutual Consultation. They shall constitute an integral and equally authentic part of the Agreement. Modification of the agreement shall not affect activities already in progress as of the date of notification.

Article 11: Termination

The parties may terminate this Agreement at any time by mutual consent. Either Party may terminate this agreement with written notification, signed by a designated official of the Party initiating termination. Such notification must be given to the other Party at least six months in advance of the effective date of termination. Undertakings still in progress at the time of termination shall continue until completion unless the parties agree otherwise in writing.

Article 12: Force Majeure

For the purpose of this agreement, "Force Majeure" means an event which could not reasonably have been avoided by a diligent Party in the circumstances, which is beyond the reasonable control of a Party and which makes a performance of its responsibilities hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances and includes, but limited to, wars, riots, civil disorders, earthquakes, storms, floods, or adverse weather conditions, strikes, lockouts or other industrial actions, terrorist acts, confiscations or any other action by government agencies.

A. Performance Excused

The failure of a party to fulfil any of its obligations hereunder shall not be considered to be a breach of or a default under, this agreement insofar, as such inability arises from an event of force majeure, provided that the party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms of this agreement.

B. Notification

A Party affected by an event of Force Majeure shall notify in writing the other Party of such an event as soon as possible and in any event not later than five (5) days following the occurrence of such event providing evidence of the nature and cause of such event, and shall similarly give restoration of normal conditions as soon as possible.

Neither party shall be liable for any delay or default if such delay in performance or other failure to perform their respective obligations under this MOU is the result of an event of Force majeure, which includes, but is not limited to, government restrictions, wars, floods, strikes, fire, etc.

Article 13: Liability

Each party assumes full responsibility for the acts or omissions of its respective employees, agents, and representatives. In no event will either Party or their offices, agents or employees be liable for any incidental, special, indirect, exemplary or consequential damages of any kinds, including business expense, loss of profits, damage or injury to property for any claims, demands or damages arising out of the existence and/or use of this MOU even if the Party has been advised of the possibility of such damages.
