- 10. Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.

i. 

Posters as per Clause 6.1 (a) that "the ragging is totally prohibited in the Institution and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations (www.ugc.ac.in) as well as under the provisions of any penal law for the time being in force" are being got printed and will be pasted by the Chairman, University Anti-Ragging committee at all important places in the University Campus.

The Committee further made the following recommendations for implementation:

- Chairman, UARC will arrange to display Flex Boards carrying anti-ragging message along with important Telephone Nos. at various prominent places on the University Campus.
- All Heads of the departments will take self-declaration from every enrolled students and their parents on the prescribed proforma.






