1.- My teaching experience in the Department of Homoeopathic Materia Medica prior to joining in Rani Dullaiya Smriti Homoeopathic Medical College & Hospital is as follows:

I joined R.K.D.F. Homoeopathic Medical College & Hospital, Research Centre, Bhopal on 25.04.2016 as Professor in the Department of Homoeopathic Materia Medica. However I was not issued any appointment letter/order mentioning one or other excuses. They used to deduct some part of Salary also frequently stating that the funds are not sufficient and they assured to pay the deducted amounts afterwards. When I did not get my Appointment order/letter and the deducted salary, I decided to leave the College. I tried to submit the notice for resignation in the month of April, 2018, but the Principal and office staff did not receive my letter saying that they have instructions from the Management not to receive any such letters. Then finally I tried to submit my resignation on 11.06.2018 and also on 12.06.2018 morning, which was again not received by them. Then I send them the resignation letter by E-mail and by Speed post on 12.06.2018 and also joined Rani Dullaiya Homoeopathic Medical College & Hospital in the afternoon of 12.06.2018.


Further it is submitted that even without counting the above period of my teaching in R.K.D.F. Homoeopathic Medical College & Hospital, Research Centre, Bhopal from 25.04.2016 to 12.06.2018, I am eligible to be appointed on the post of Professor in the Department of Homoeopathic Materia Medica as per the provisions of HCC (MSR) Regulations, 2013, since I am already having a total teaching experience of more than 24 years including more than 15 years teaching experience as the Professor in the Department of Homoeopathic Materia Medica and excluding the period of experience in R.K.D.F.
