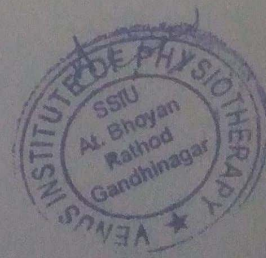
Dear Sir,



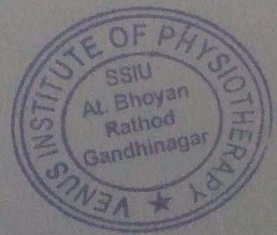


