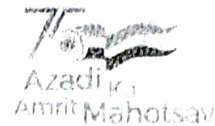



You may please contact our EE, UGVCL, GANDHINAGAR U who will arrange for physical release of supply, for which you have to submit: 1) The Test Report of Electric Wiring of your premises with fees of Rs.20.00, 2) Charging approval of Electrical Inspector for Transformer, VCB etc, 3) VCB approval of UGVCL for contract demand equal or more than 500 KVA.

From the date of release or deemed date of release of power supply, you will be billed on the basis of contract demand of 150 KVA on tariff HTP-I (One).

Before release of this load, you shall provide separate metering arrangement at your cost so as to record energy consumed for non-industrial load.

You shall be responsible for obtaining and maintaining all applicable statutory approvals including Consent to Establish, Consolidated Consent and Authorization from Gujarat Pollution Control Board. Your Electrical connection is liable to be disconnected on directives from any of such Statutory Authorities for non-compliance of the required Approvals.

As per Supply Code provision, if you failed to avail this power supply within Sixty Days from the date of issue of this letter, you will be billed on the basis of contract demand of 150 KVA for monthly minimum charges after expiry of Sixty Days from the date of issue of this letter as per provision of tariff as imposed from time to time.

NOTE:

- Before release of connection you have to Submit on Rs.300/- notarized consent for not claimming regarding revenue loss occurred due to interruption of 11 Krushnagar JGY Feeder & in future the connection is transferred from JGY to Ind. feeder, then you have to make payment for the line charge.
- Before release of connection clear all pending dues as per norm.
- You have to construct complete compound wall surrounding your approved area & To provide the gate near point of supply.
